Since the issuance of AD F-2001-087-062 and AD F-2001-088-082, the Type Certificate Holder designed the Modification 073166 to improve the attachments of the rear bench seat. The present AD supersedes DGAC France AD F-2001-087-062 and AD F-2001-088-082, but retains their limitations for rotorcrafts non-modified per Mod 073166 [AS 350 Service Bulletin (SB) No.25.00.70 or AS 355 SB No.25.00.66] and identifies MOD 073166 as optional terminating action for such limitations.
