<p>This AD is issued in accordance with EC 1702/2003, Part 21A.3B. In accordance with EC 2042/2003 Annex I, Part M.A.301, the continuing airworthiness of an aircraft shall be ensured by accomplishing any applicable ADs. Consequently, no person may operate an aircraft to which an AD applies, except in accordance with the requirements of that AD unless otherwise specified by the Agency [EC 2042/2003 Annex I, Part M.A.303] or agreed with the Authority of the State of Registry [EC 216/2008, Article 14(4) exemption].</p>

Reason:	<p>EASA AD No. 2006-0252 has been issued following a case of untimely unlocking of the "hoist operator's belt" snap hook. Unlocking can put the operator in danger when using the hoist.</p> <p>It has been reported that the application of AD No. 2006-0252 was not possible on SE 3160, SA 316 B and C, and SA 319 B helicopters due to an incompatibility between the new quick release shackle introduced by the AD and the retaining cable end-piece.</p> <p>Consequently this AD supersedes AD No. 2006-0252 retaining its requirements, except for SE 3160, SA 316 B and C, SA 319 B helicopters for which it is additionally required to install a modified cable end-piece and a new compliance time has been defined.</p>

Required action(s) and Compliance Time(s):	<p>Required as indicated, unless accomplished previously:</p> <p>1 – For all helicopters listed in the section "Applicability" here above, the following measure is mandatory as from 03 July 2004, the effective date of DGAC AD No. F-2004-096 (superseded by EASA AD No. 2006-0252):</p> <p>Each time before using the "hoist operator's belt" secure the locking mechanism of lever-type snap hook P/N GA343-95 or 4100-80AT28, in accordance with the instructions specified in paragraph 2.B. of EUROCOPTER Alert Service Bulletin (ASB) corresponding to the helicopter version listed in paragraph 1 of the "Ref. Publications" section of this AD.</p> <p>2 – For all helicopters listed in the section "Applicability" here above, <u>except</u> SE 3160, SA 316 B and C and SA 319 B helicopters, the following measure is mandatory as from 01 September 2006, the effective date of EASA AD No. 2006-0252:</p> <p>2.1. At the latest by 31 December 2006, remove the lever-type snap hook, P/N GA343-95 or P/N 4100-80AT28, and replace it with a quick-release shackle P/N 365A84-5033-20, in compliance with the instructions specified in paragraph 2.B. of the ASB corresponding to the helicopter version listed in paragraph 2 of the "Ref. Publications" section of this AD.</p> <p>2.2. After 31 December 2006, no person shall install operators' belts and lever-type snap hooks on a helicopter, unless modified in accordance with the instructions specified in paragraph 2.B.6.a. and 2.B.6.b. of the ASB corresponding to the helicopter version listed in paragraph 2 of the "Ref. Publications" section of this AD.</p> <p>NOTE 2: Replacing the lever-type snap hook with the quick-release shackle terminates the requirements of paragraph 1 above.</p> <p>3 – For SE 3160, SA 316 B and C and SA 319 B helicopters, the following measure is mandatory at the latest by 6 months after the effective date of this AD:</p> <p>3.1. In accordance with the instructions specified in paragraph 2.B. of ASB No. 25.69 revision 1 remove and replace :</p> <p style="padding-left: 40px;">- the lever-type snap hook P/N 4100-80AT28 by a quick-release shackle P/N 365A84-5033-20, and</p>

After 6 months from the effective date of this AD no person shall install operators' belts and lever-type snap hooks on a helicopter, unless modified in accordance with the instructions specified in paragraph 2.B.6.a. and 2.B.6.b. of ASB No. 25.69 revision 1.</p> <p>NOTE 3: Replacing the lever-type snap hook with the quick-release shackle terminates the requirements of paragraph 1 above.</p>
