## Antonov An-2 airplanes

Implementation of the Instruction for continued airworthiness for the Antonov  
An-2 airplanes (all modifications) № 02.00.00.000.000

### 1. Reason of the Directive issue.

In order to improvement of the Antonov An-2 airplanes (all modifications) continued airworthiness and unify the maintenance and airworthiness limitations, on 26.04.2012 it is issued the Instruction for continued airworthiness № 02.00.00.000.000 for Antonov An-2 airplanes (all modifications) that contains information about the life and time limits of Antonov An-2 airplanes and their systems and about conditions for serving out of these limits, information about the life and time limits of engines, propellers, components, parts, details and equipment.

Non-compliance with the requirements for the maintenance and airworthiness limitations contained in the Instruction for continued airworthiness for the Antonov An-2 airplanes may result in a unsafe condition of the aircraft.

### 2. Applicability.

This Directive is applicable to all Antonov An-2 airplanes (all modifications).

### 3. Corrective actions.

Operation Antonov An-2 aircraft should carry out in accordance with Instruction for airworthiness Antonov An-2 airplanes (all modifications), № 02.00.00.000.000 or later issues approved by the State Aviation Administration of Ukraine.

Bulletins and other documents containing information about the life and time limits of Antonov An-2 airplanes and their systems and about conditions for serving out of these limits, information about the life and time limits of engines, propellers, components, parts, details and equipment are considered as repealed.

### 4. Effective date.

The Directive comes into effect on the date of its signing.
