Reason:	After some incidents initiated by electrical short circuit behind a side wall, in which the flammability characteristics of thermal/acoustical insulation material made from metallised polyethyleneteraphthalate (MPET) may have been a contributing factor, DGAC France (being the competent Certification Authority at that time) decided to improve flammability standards for thermal/acoustical insulation materials. As consequence, new requirements were issued and the MPET (also called metallised Mylar) must be replaced on all aeroplanes. Although no incident has ever been experienced on ATR aeroplanes equipped with MPET, DGAC France issued AD F-2005-211, approved by EASA, to require the improvement of fire safety standard of the insulation blankets installed on ATR aircraft.
