NOTIFICATION

EXEMPTION FOR LICENSING OF SAILPLANE PILOTS

The Civil Aviation Authority of the Czech Republic in accordance with the article 71 (1) of the 2018/1139 EU regulation (Basic Regulation) has granted an exemption by declaration of the Director of the Flight Division from FCL.130.S, FCL.140.S, FCL.230.S, FCL.805, FCL.815, FCL.830 and FCL.940 requirements of the EU 1178/2011 regulation (Aircrew Regulation) and SFCL.155, SFCL.160, SFCL.205 and SFCL.215 of the EU 2018/1976 regulation (Sailplane Pilot Regulation) valid for ratings endorsed in the licences of sailplane pilots issued by the Civil Aviation Authority of the Czech Republic and privileges endorsed in log books (the Exemption).

1. Applicable Licences, Ratings and Privileges – Sailplane pilot:

The Exemption has been granted for holders of the SPL or LAPL(S) and the following endorsed ratings and privileges issued according to Part-FCL or Part-SFCL (the Applicants):

- (1) SAILPLANE
- (2) TMG
- (3) TOWING-S/BAN
- (4) MOUNTAIN-W/S
- (5) CLOUD
- (6) FI(S) SPL/LAPL(S), TMG, AEROBATICS-S/TMG, TOWING-S/BAN, NIGHT, CLOUD, FI(S)+
- (7) Launching privileges WINCH / CAR / AERO TOW / SELF / BUNGEE.

2. Validity Period of the Exemption:

- (1) When the validity of the following recency set out to the last 24 months prior to the planned flight according to FCL.140.S, FCL.230.S or SFCL.160 ends within the period from 01.03.2020 till 31.07.2020:
 - (a) SAILPLANE
 - (b) TMG

it is extended to the last 30 months.

- (2) When the validity of the following recency set out to the last 2 years according to FCL.130.S, SFCL.155, FCL.805, SFCL.205, FCL.805 or SFCL.215 to retain relevant privileges ends within the period from 01.03.2020 till 31.07.2020:
 - (a) launching methods
 - (b) TOWING-S/BAN rating
 - (c) CLOUD rating.

it is extended to the last 2 years and 8 months.

(3) When the validity period of any of the FI(S) rating according to FCL.940 ends within the period from 01.03.2020 till 31.07.2020 it is **extended by 8 months**.

3. Conditions of the Exemption:

The Exemption is granted only in the case when a holder of the applicable licence / rating / privilege is not able to meet requirements for its recency / revalidation in a usual way due to measures having been applied to fight spread of the COVID-19 virus, i.e. particularly limitation of movement of persons, actions of pilot-examiners and instructors, access to the base aerodrome and when the following requirements have been met:

- (1) Recency of the SAILPLANE, TMG, TOWING-S/BAN, CLOUD rating and launching method privileges:
 - (a) The applicant shall have received briefing from an instructor who holds relevant instructional privileges (the Instructor) in order to refresh the required level of theoretical knowledge to safely operate the applicable aircraft and to safely carry out the relevant manoeuvres and procedures. That briefing shall include specific abnormal and emergency procedures.
 - (b) The instructor endorses and signs the received briefing according to the subpara above into the applicant's Log Book by words: "Received briefing according to CAA CZ exemption Re 1748-20-301 dated 08.04.2020 to extend the following recency (DD.MM.YYYY)."
- (2) Revalidation of the FI(S) rating: The validity period of the rating shall end in the period from 01.03.2020 till 31.07.2020.
- (3) Revalidation of the MOUNTAIN-W/S rating according to FCL.815: Is made by a foreign EASA examiner / instructor who is privileged to do so according to the rules established by the Aviation Authority that issued his examiner / instructor certificate.

4. Procedures for Grant of the Exemption:

(1) **All recency cases:** The Exemption is granted automatically as soon as the Applicant has met relevant requirements specified in this Notification including the above endorsement into his Log Book.

(2) FI(S) revalidation:

- (a) A FE(S) checks out that the Applicant has met relevant requirements of this Notification.
- (b) The FE(S) endorses the extended validity of the FI(S) rating into the Applicant's pilot licence.
- (c) The FE(S) fills in the Applicant's data into the NOTIFICATION OF EXEMPTION REVALIDATION OF FI(S) RATING form and sends it together with the copy of

the applicant's pilot licence with the revalidated FI(S) rating via e-mail to: podatelna@caa.cz .
