#### NOTIFICATION OF EXEMPTIONS

## LICENCE RATINGS OF PROFESSIONAL PILOTS

The Civil Aviation Authority of the Czech Republic in accordance with the article 71 (1) of the 2018/1139 EU regulation (Basic Regulation) has granted an exemption from Part-FCL.055, FCL.625, FCL.740 and FCL.940 requirements of the EU 1178/2011 regulation (Aircrew Regulation) valid for some ratings endorsed in pilot licences issued by the Civil Aviation Authority of the Czech Republic.

# 1. Applicable Ratings

The exemption has been granted only for the following ratings endorsed in CPLs, MPLs or ATPLs issued according to Part-FCL for aircraft operated by an organisation where Part-ORO requirements of the EU 965/2012 regulation (Operations of Aircraft) are applied.

- (1) Class, type and instrument ratings including PBN and LVO
- (2) Instructor ratings
- (3) ICAO English language ratings

#### 2. Validity Period of the Exemption

- (1) When the validity period of the class, type or instrument rating including PBN or LVO ends within the period from 16.03.2020 till 31.07.2020 its validity period is extended by 4 months.
- (2) When the validity period of an instructor or language rating ends in the period from 16.03.2020 till 31.07.2020 its validity period is extended until 31.07.2020.

#### 3. Conditions of the Exemption

The exemption is granted only in the case when a holder of the applicable rating is not able to meet requirements for its revalidation in a usual way due to measures having been applied to fight spread of the COVID-19 virus, i.e. particularly limitation of movement of persons, operations of flight simulation and training devices, pilot-examiners and organisations or persons authorised to conduct ICAO English proficiency tests and when the following requirements have been met:

#### (1) Revalidation of a class / type / instrument rating:

- a. The applicable class / type / instrument rating shall be valid on the day of the exemption grant, and
- b. The applicant has received specific refresher training and has completed an assessment according to operator's requirements to determine that the

required level of knowledge to operate the applicable aircraft class / type / instrument rating is maintained. That assessment shall include class / type specific abnormal and emergency procedures.

(2) **Revalidation of an instructor or language rating:** The applicable instructor or language rating shall be valid on the day of the exemption grant.

### 4. Procedures for grant of the exemption:

- (1) The applicant has met the requirements specified in subpara 3. (1), optionally 3. (2).
- (2) An adequately qualified examiner nominated for the purposes of this exemption by the operator and notified to the Civil Aviation Authority of the Czech Republic in advance (The Examiner) checks that the above mentioned requirements have been met.
- (3) The Examiner endorses the extended validity of the applicable instructor or language rating into the applicant's pilot licence.
- (4) The Examiner fills in the form DECLARATION OF THE OPERATOR NOTIFICATION OF EXEMPTIONS / LICENCE RATINGS OF PROFESSIONAL PILOTS for all applicants of the relevant operator who he has extended the validity period of their ratings to using this exemption and sends it together with copies of the pilot licences with extended ratings via email to: podatelna@caa.cz.
