#### **NOTIFICATION**

# EXEMPTION FOR LICENSING OF AEROPLANE AND HELICOPTER PILOTS IN GENERAL AVIATION

The Civil Aviation Authority of the Czech Republic in accordance with the article 71 (1) of the 2018/1139 EU regulation (Basic Regulation) has granted an exemption by declaration of the Director of the Flight Division from Part-FCL.055, FCL.625, FCL.740, FCL.825 a FCL.940 requirements of the EU 1178/2011 regulation (Aircrew Regulation) valid for ratings endorsed in aeroplane and helicopter pilot licences issued by the Civil Aviation Authority of the Czech Republic the Exemption).

### 1. Applicable Ratings:

The Exemption has been granted for the following ratings endorsed in aeroplane and helicopter pilot licences issued according to Part-FCL for aircraft operated off the organisations where Part-ORO requirements of the EU 965/2012 regulation (Operations of Aircraft) are applied:

- (1) Class, type and instrument ratings including PBN and LVO
- (2) Instructor ratings
- (3) ICAO English language ratings
- (4) MOUNTAIN ratings (flights to mountain aerodromes where it is required).

# 2. Validity Period of the Exemption:

- (1) When the validity period of the class, type, instrument or mountain rating ends within the period from 16.03.2020 till 31.07.2020 its validity period is extended by 4 months or until 31.07.2020, whichever time period is shorter.
- (2) When the validity period of the instructor or language rating ends within the period from 16.03.2020 till 31.07.2020 its validity period is extended until 31.07.2020.

#### 3. Conditions of the Exemption:

The Exemption is granted only in the case when a holder of the applicable rating is not able to meet requirements for its revalidation in a usual way due to measures having been applied to fight spread of the COVID-19 virus, i.e. particularly limitation of movement of persons, operations of flight simulation and training devices, pilot-examiners and organisations or persons authorised to conduct ICAO English proficiency tests and when the following requirements have been met:

# (1) Revalidation of a class / type / instrument rating:

- (a) The applicable class / type / instrument rating shall be valid on the day of the Exemption grant.
- (b) The applicant shall have received, during the application period of the Exemption, a briefing from an instructor who holds relevant instructional privileges in order to refresh the required level of theoretical knowledge to safely operate the applicable class or type of aircraft and to safely carry out the relevant manoeuvres and procedures. That briefing shall include class / type specific abnormal and emergency procedures.
- (c) The instructor privileged to provide relevant training (the Instructor) endorses and signs the received briefing according to subpara 3. (1)(b) of this notification into the applicant's log book by words: "Received briefing according to CAA CZ exemption Re 1696-20-301 dated 06.04.2020 for revalidation of the ....... rating."
- (2) **Revalidation of instructor or language rating:** The applicable rating shall be valid on the day of the Exemption grant.
- (3) **Revalidation of the MOUNTAIN rating:** Is made by a foreign EASA examiner / instructor who is privileged to do so according to the rules established by the Aviation Authority that issued his examiner / instructor certificate.

# 4. Procedures for Grant of the Exemption:

- (1) The applicant has met the requirements specified in subpara 3. (1), optionally 3. (2).
- (2) An examiner having adequate privileges (the Examiner) checks out that the above mentioned requirements have been met.
- (3) The Examiner endorses the extended validity of the applicable class / type / instrument or instructor or language rating into the applicant's pilot licence.
- (4) The Examiner fills in the data of the applicant to whom he has extended a rating into the NOTIFICATION OF EXEMPTION REVALIDATION OF LICENCE RATINGS GENERAL AVIATION PILOT OF AEROPLANE / HELICOPTER form and sends it together with copies of the licences with extended ratings via e-mail to: <a href="mailto:podatelna@caa.cz">podatelna@caa.cz</a>. The Examiner can use a single notification form for several applicants.
